

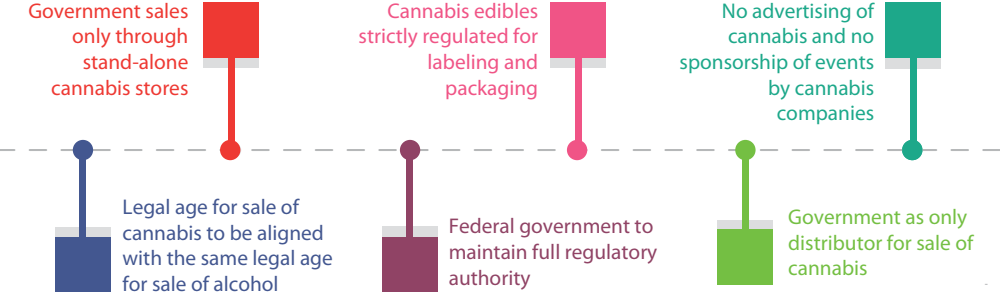
CANNABIS CONVERSATIONS

Managing the harms of legalized cannabis: IFNS recommendations for a regulatory framework:

A public health approach is required when cannabis becomes legalized in Canada. The health of all Canadians must take precedence over revenue generation. Government must hold a complete monopoly on cannabis sales, which includes distribution/access, pricing and advertising of all cannabis products.
